2.	<b>Deposit</b>	A deposit <b>equal to 50% of the entire stay</b> is required at the time of booking unless otherwise agreed by us. Deposits are payable by credit card or debit card. Deposits paid for reservations made under a Special Offer are <b>non-refundable</b> .
6a.	<b>Cancellation or Truncation (By You)</b>	Where a room is cancelled; where the duration of the stay is reduced less than 7 days prior to the original booked arrival date; where you fail to arrive ("no-show"); or where you leave before your due departure date, we reserve the right to charge the full balance for your original booked stay.
6c.	<b>Transferability</b>	At our sole discretion, we may permit the reservation to be moved to alternative dates. Any such alteration will be subject to availability of rooms and the continuing validity of the Special Offer. In such circumstances, we cannot guarantee to provide the same room, or same type of room as originally reserved.  Where alternative dates fall outside the validity of the Special Offer, the normal rate in force will then apply. The deposit shall remain non-refundable and will be applied to the revised reservation.  Where alternative dates are agreed by us, clause 6a shall then apply to the revised arrival date.
